**SHOW RULES:** This show will be governed by all ACFA Show Rules & Bylaws. These may be obtained by sending \$7.50 to: ACFA Central Office, P.O. Box 1949, Nixa, MO 65174.

**NOTE:** All cats **MUST** be accompanied by the owner or designated agent.

**LIABILITY:** Although Hoosier Hisser Cat Club takes every possible care, neither it, nor the Show Management can be held liable for the loss of property or accident to the cats or exhibitors.

**VETTING:** All cats/kittens must be vaccinated two weeks prior to show time for your safety and the health of the cat. Any cats showing signs of being ill will be asked to leave the show hall and required to be examined by a veterinarian prior to being allowed back into the show.

**AWARDS:** Final awards will be awarded in all rings as specified by ACFA show rules. Cash donations to the award fund will be greatly appreciated and acknowledged in the show catalog. Permanent flats will be used for class and breed wins. Registered cats with their number in the catalog will be scored for ACFA Regional and Inter-American awards. Call ACFA today to register your cats: (417) 725-1530.

**CAGES/NOVICE EXHIBITORS:** Bring grooming aids and curtains or towels for the cages, which are about 24" deep, 24" wide and 22" high.

**LITTER AND FOOD:** Litter will be furnished. Litter pans will not be provided.

**PEOPLE FOOD:** Pizza Hut Buffet will be available for \$8 per person at the break for lunch. There will be small snacks and beverages available for purchase in the morning

**HOUSEHOLD PETS (HHP):** Household pets, adult and kittens together, will be judged in all rings. Please indicate if your HHP is long or short haired. Per show rules, HHP kittens, 4 months to 8 months of age, may be altered or unaltered. Adults, 8 months and older, must be altered for registration and show. Any entry that is known to be of non-Felis Catus ancestry will not be permitted to be entered into the show.

**TRANSFERS:** Transfers will be accepted by the Master Clerk during the show on Saturday. Bring information from your prior wins.

**CLERKS:** We will pay clerks \$55 for the day. Please, indicate on your entry form if you would be willing to clerk. Submit entry forms and fees for all cats. We will notify you if you are needed to clerk. You will be paid after the show. Lunch and beverages will also be provided. We need and appreciate you!!

**ADVERTISING:** \$25 for full page; \$15 for 1/2 page; \$10 for 1/4 page; \$5 for business cards. Front and back inside covers & back cover for \$50 for ¼ page.

**VENDORS:** A limited number of sales booth spaces are available (8 foot table area). No one is permitted to sell anything from their cages. Please contact the entry clerk or show managers for vending space
