

Closing Date: Registration via mail will close on April 17, 2024 (EClerk deadline April 20, 10am). If you have not received your confirmation by April 19, 2024, please call the entry clerk for confirmation that your entry was received. Gopher State Cat Club is not responsible for entries lost or delayed in the mail (this includes email.)

Check-In: Saturday - 7:30 to 8:30 A.M. with judging starting at 9:00 A.M. Sunday - 8:00 to 8:30 A.M. with judging starting at 9:00 A.M. Anyone not checked in by end of check-in will be marked absent. You must be present to claim all final awards unless PRIOR PERMISSION IS RECEIVED FROM THE SHOW MANAGER. The show will be scored for ACFA Inter-American and Regional awards. Advertised show hours will be from 9 AM - 4 PM.

Show Rules: This show will be conducted according to the rules of the American Cat Fanciers Association (ACFA). It is the responsibility of each exhibitor to know the show rules. A copy of the show rules is available for \$7.00 from ACFA, P.O. Box 1949, Nixa, MO 65714-1949 or on the ACFA web site, http://www.acfacats.com.

Liability: Neither the show management, nor any member of the club can be held liable for the loss of, or accident to, the cats, carriers or other personal property of any exhibitor or injury to any person, animal or property. We reserve the right to refuse any admission and to remove any person or animal from the show hall in the best interest of the show and exhibitors.

Clerks: Clerks will be paid the equivalent of one entry fee for clerking both days. Lunch will be provided. If interested, please indicate on your entry form. Clerks will be assigned according to experience and will be paid at the end of the show. Please do not deduct from your fees.

Children: This show is for the display and competition of cats. While well-behaved children are welcome, two days at a show can be very boring and tiring for them. If an exhibitor or spectator brings a disruptive child to the show hall, the child will be asked to leave. There will be no refund of entry or admission fees.

Health: This is a non-vetted show; no veterinary inspection will be required prior to benching. All entries must be inoculated against Feline Enteritis, Rhinotracheitis, Calici Virus and rabies. Entries must be free of fleas, ear mites and fungus. Any entry(s) from a household where there has been a feline infectious illness within 21 days prior to the show will not be allowed in the show hall. All cats/kittens must have their front and back claws trimmed or it will be done at the show at the exhibitor's expense.

Kittens: No kitten under the age of 4 months will be allowed in the show hall. No cats or kittens will be allowed to be kept under the show bench or under grooming tables. Kittens in the show hall must have been born on or before December 27 (for Saturday) or 28 (for Sunday), 2023.

Supplies & Cages: The club will provide litter. Bring your own food and water dishes, cat food and litter pans. Single cages (included with entry fee) are 22x22x25". Double cages are 22x22x54". Novice exhibitor: Please bring coverings for the top, sides and bottom of the cage.

Sales Cages: Sales cages will be available only to exhibitors. Minimum price for a cat or kitten is \$125.00. No sales are permitted from carriers under the table or from vehicles in the parking lot.

Food: People food will be available in the show hall. This is a non-smoking show hall.

Household Pets: Household pets will be judged in all eight rings. They must be immunized at least three weeks prior to the show and if they are over eight months old, they must be spayed or neutered. Although a household pet may be declawed, all remaining claws must be trimmed.

Transfers: Transfers for the show must be made with the Master Clerk before the start of each session of the show. All championship entries should be registered before the show. Novice exhibitors: If your cat wins enough points on Saturday, you will need to make a transfer. We will be happy to help you with the paperwork.
