> 22x22x44. Bring your dishes for food, water and litter pan. Bring cage curtains. No kitten under the age of four months old on the day of the show will be allowed in the show hall. No cat or kitten may be sold for less than \$125.00 at this show since the club supports serious breeders. No sales are permitted from carriers under the table. Must have a health certificate on all cats or kittens for sale.
