

Catzville Junction's Cat Club ACFA Cat Show– December 28, 2018

General Information Closing Date: Registration will close on December 23, 2018 at Midnight or when the 100th entry is received whichever comes first. Catzville Junction Cat Club (CJCC) is not responsible for entries lost or delayed in the mail. Check-In Saturday: 7:00-7:30 am. Judging will start at 8 am. Anyone not checked in by 7:30 am will be marked absent. There will be no PM Check-In. Judging begins at 1 pm ** NOTE: Please bring a copy of your Entry Forms and Confirmation (in case they are required for verification of entries).

Show Hall: Vendors will be on site. The show hall is climate controlled and fully wheelchair accessible. There is no smoking allowed in the show hall.

Benching: No cats/kittens are allowed to be kept under the show bench or under grooming table in carriers (except while setting up/ tearing down). Benching kennels supplied by the show are wire, sizes are 21"x21"x22" for a single (double divided) and 21"x21"x45" for double. Novice exhibitors, bring kennel curtains (coverings for the top, sides and bottom of the kennel). You can request to be benched beside another exhibitor. No change of benching assignments will be made without permission of show management. No cats/kittens may be kept in the show hall overnight. Cats must remain in the show hall during advertised show hours unless written permission is received by show management.

Supplies: Litter is provided; please bring your own litter pan, food & water, and dishes for your felines. Health: This is a non-vetted show – no veterinary inspection will be required prior to benching. It is necessary that all cats be inoculated at least 30 days in advance of the show for Rhinotracheitis (Feline Herpes Virus), Calici, and Panleucopenia (Enteritis). Proof may be requested, so kindly bring your cats' inoculation records. Entries must be free of fleas, ear mites and fungus. Pregnant/lactating queens are not permitted in competition. Declawed cats are permitted, as are clear nail caps. All claws must be clipped prior to showing. If this is not done, it will be performed at a charge of \$8.00 per cat. Kittens: No kittens under the age of 4 months will be allowed in the show hall. Kittens in the show must have been born between August 29, 2018 and December 29, 2018.

Household Pets: All Household Pets over the age of 8 months MUST BE ALTERED to be recorded in ACFA or shown. Kittens shown in Household Pet class may be altered or unaltered.

Cat & Kitten Sales: Sales cages are available only to registered breeders who are also exhibiting cats or kittens at this show. Cats and kittens for sale must have proof of Litter or Individual Registration. For minimum age, see "Kittens", above. ACFA Registration: A cat may be entered in Championship with the Registration # pending. Breeds that MUST HAVE A REGISTRATION # to be shown are Bengal, Korat, Pixie Bob, and Singapura, and all NBC (New Breed or Color) class cats. Listing Fee: You may enter a cat in Championship that is not ACFA Registered by paying a Listing Fee (see Entry Summary Form). A registration number must be provided for all Championship entries by the morning of the show or you will be charged the Listing Fee. Championship Cats and Alters can be shown only once without a registration number. This does not apply to Kittens or Household Pets. Awards: Rosettes will be awarded in all Rings according to ACFA Show Rules. Cats must be present to collect all Final awards unless prior permission is received from the Show Manager. ACFA registered/recorded cats will be scored for ACFA Regional and InterAmerican awards.

Back-to-Back Show Transfers: For AM-PM Back-to-Back shows, transfers to a higher class (Champion \$12 US or Grand Champion \$17 US) for PM's show due to wins on AM's show will be accepted by the Master Clerk during the

show on AM and prior to judging on PM. Payment must be included. Bring information from wins at prior shows if applicable. No transfers will be accepted on PM after judging begins.

Liability: Although CJCC takes every possible care, the Club, the Show Management, or The American Cat Fanciers Association, Inc. cannot be held liable for loss, damage, injury, or accidents to cats, people, or property. CJCC reserves the right to refuse entry or remove any persons or animal from show hall for any reason deemed in the best interest of the show. Entry fees will not be refunded. Adults will be held responsible for the proper behavior of children accompanying them.
